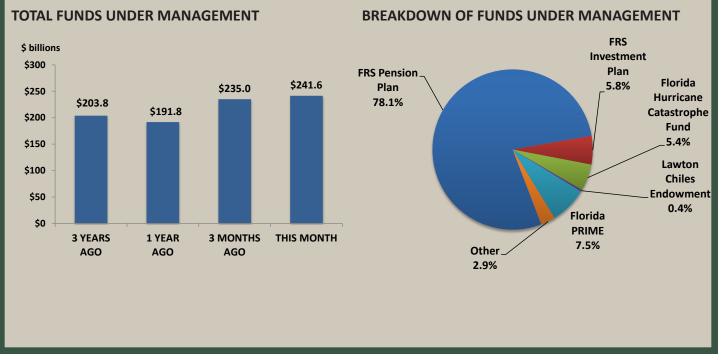

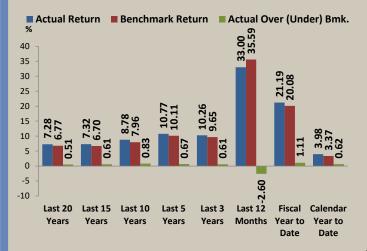

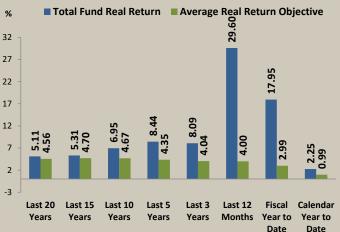

REAL RETURNS¹ (RETURNS NET OF INFLATION)



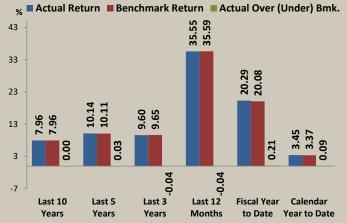

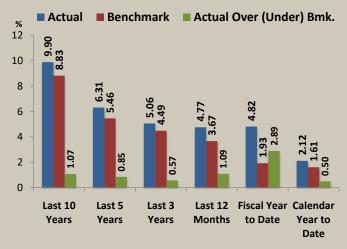

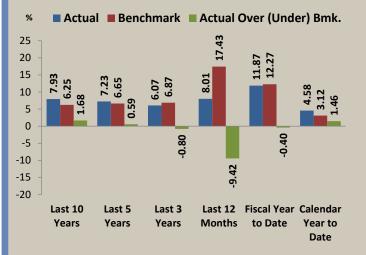

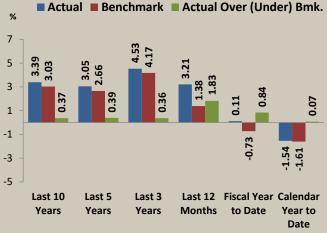
REAL ESTATE PERFORMANCE¹



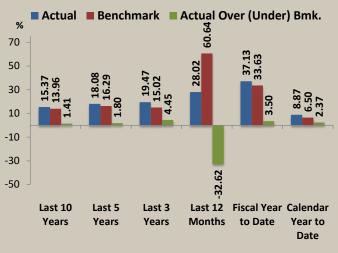
STRATEGIC INVESTMENTS PERFORMANCE¹

The enhanced monitoring and escalation standards in these charts reflect bands of acceptable active risk levels as established in SBA policy.

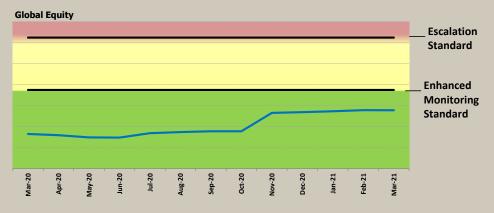

TOTAL FUND RISK



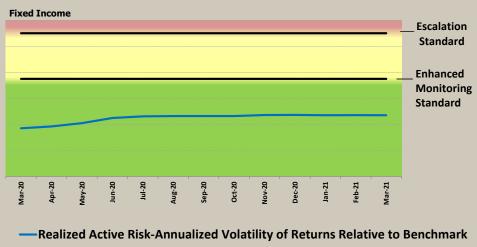

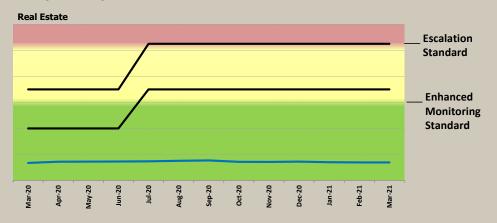

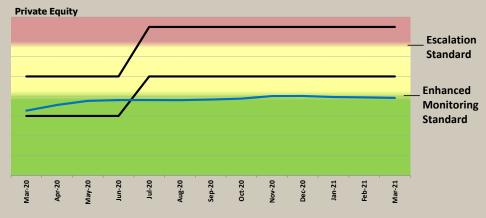

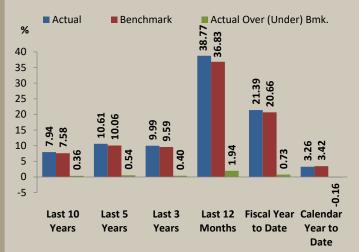

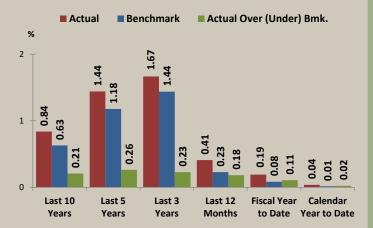

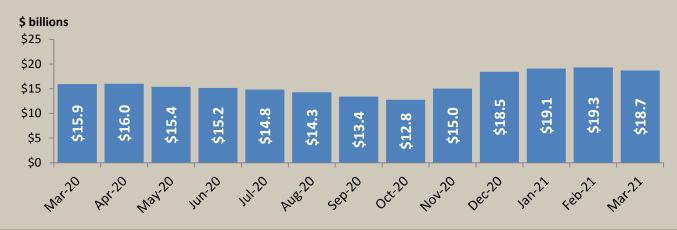

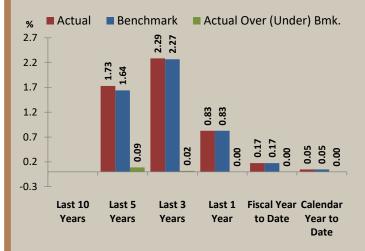

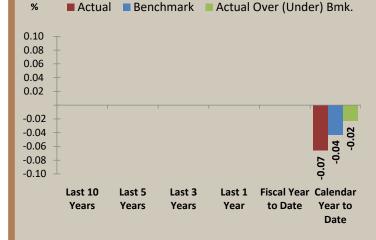

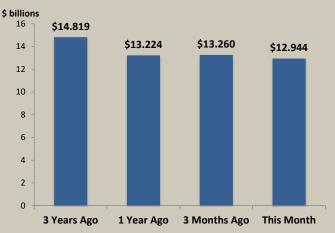
2016 NOTE PROCEEDS PERFORMANCE

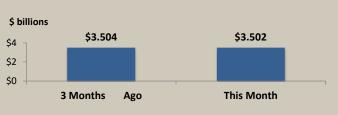
OPERATING FUND NET ASSET VALUES
