





**NET ASSET VALUES** 




#### **REAL RETURNS<sup>1</sup>** (RETURNS NET OF INFLATION)






#### **GLOBAL EQUITY PERFORMANCE**



#### **REAL ESTATE PERFORMANCE<sup>1</sup>**




#### STRATEGIC INVESTMENTS PERFORMANCE<sup>1</sup>






The SBA monitors investment risks relative to established targets. This is referred to as active risk.

Realized active risk represents the volatility of investment performance returns achieved relative to the target benchmark on a 36 month rolling basis.


The enhanced monitoring and escalation standards in these charts reflect bands of acceptable active risk levels as established in SBA policy.




GLOBAL EQUITY RISK







#### **REAL ESTATE RISK**





#### **PRIVATE EQUITY RISK**














**PORTFOLIO COMPOSITION** 



#### PARTICIPANTS BY TYPE - 731 TOTAL




### **EFFECTIVE MATURITY SCHEDULE**






#### **OPERATING FUND PERFORMANCE**




#### 2013A NOTE PROCEEDS PERFORMANCE




**2016 NOTE PROCEEDS PERFORMANCE** 




#### **OPERATING FUND NET ASSET VALUES**
