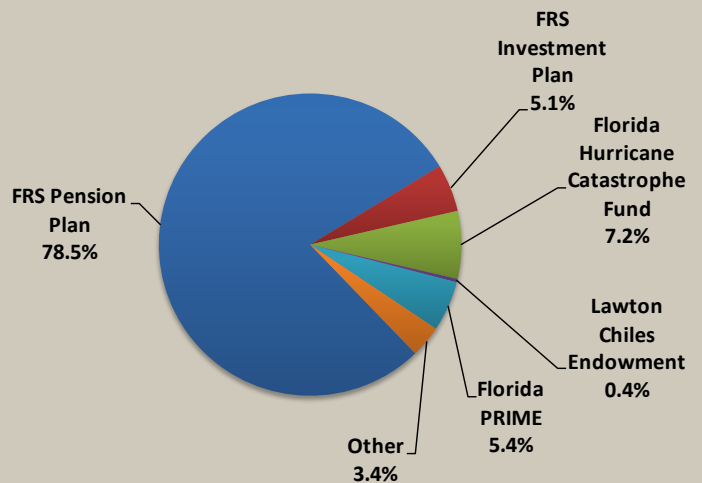

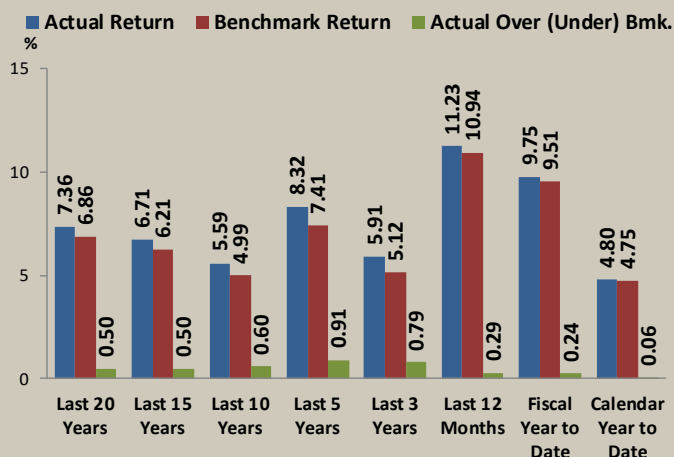

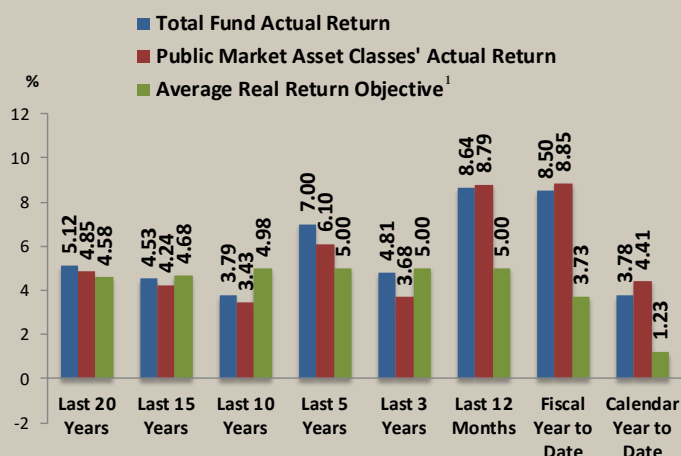

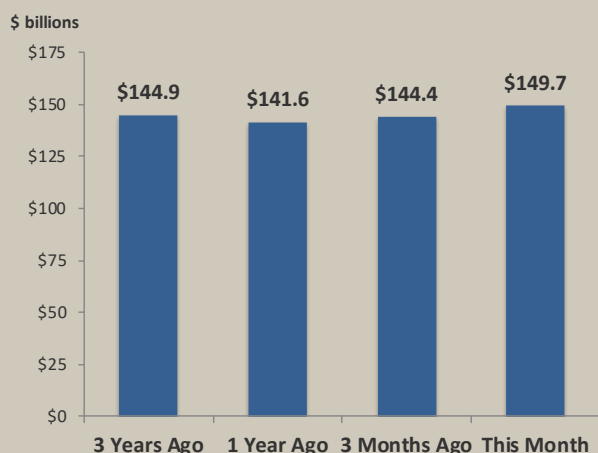


REAL RETURNS (RETURNS NET OF INFLATION)

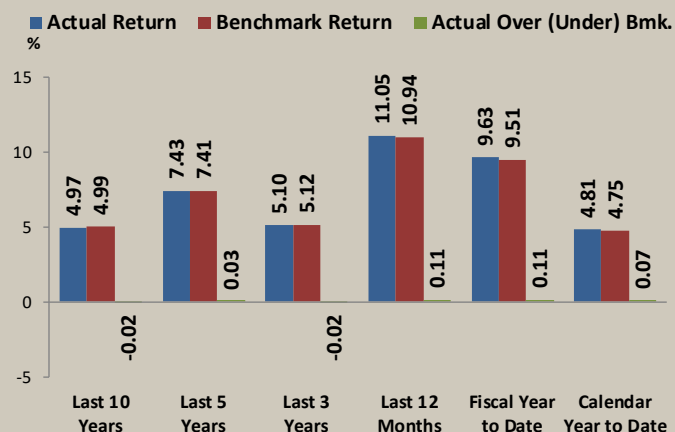

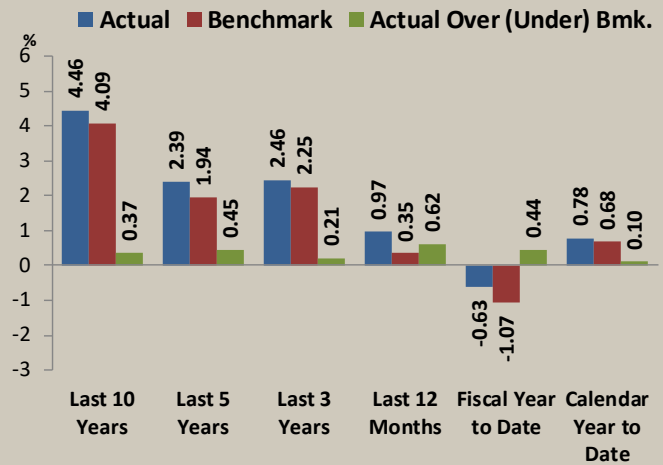

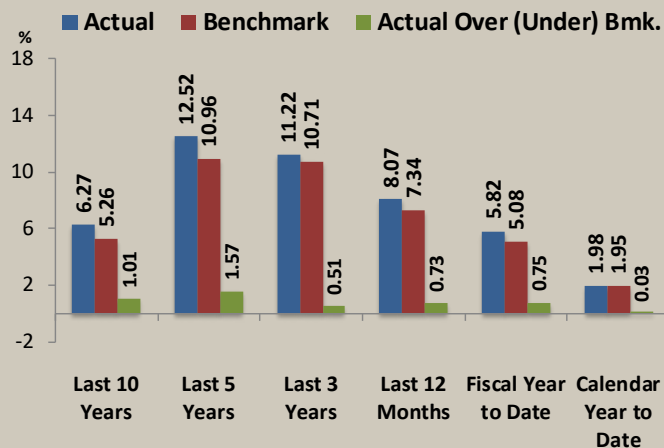
GLOBAL EQUITY PERFORMANCE



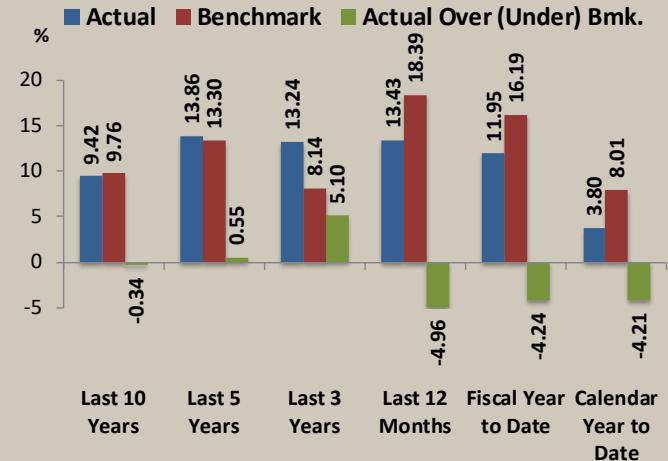
FIXED INCOME PERFORMANCE



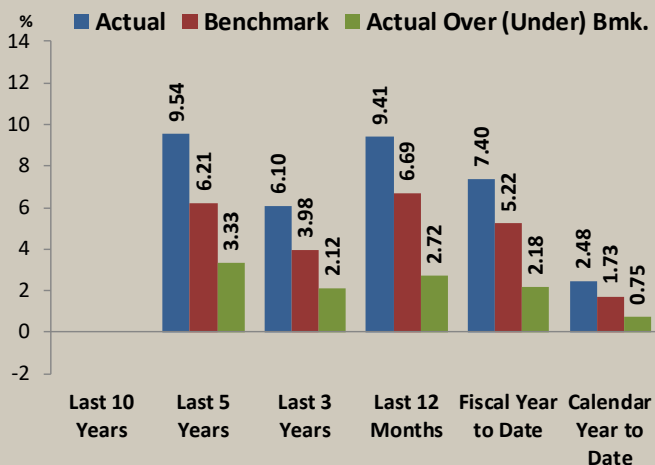
REAL ESTATE PERFORMANCE¹



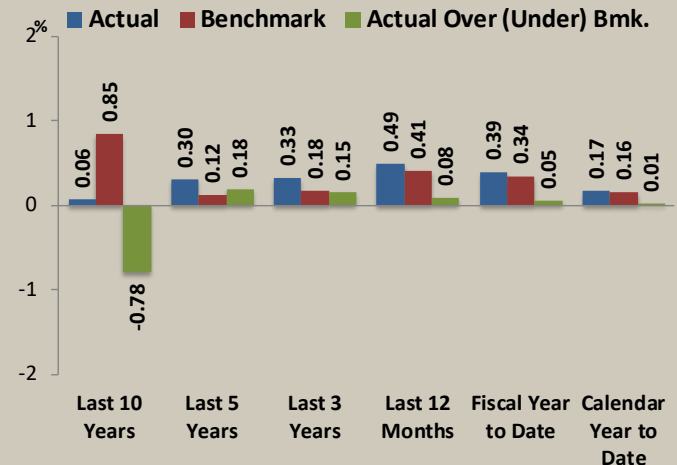
PRIVATE EQUITY PERFORMANCE¹

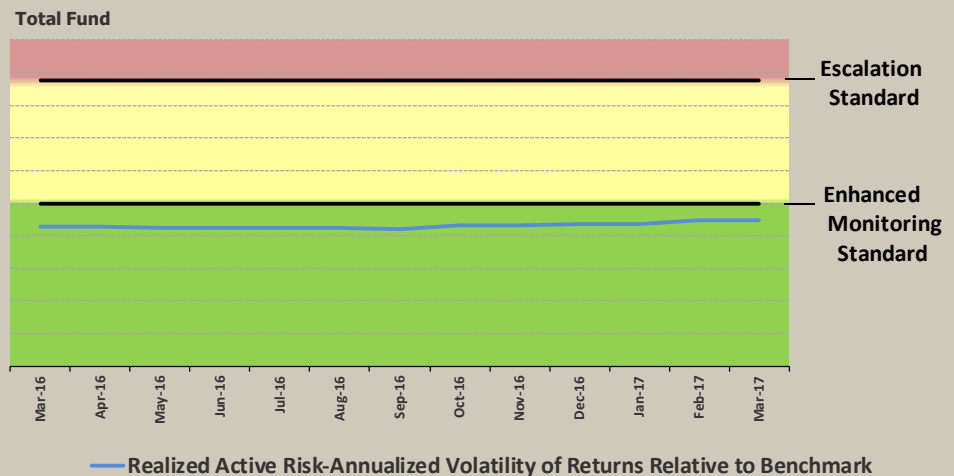
The SBA monitors investment risks relative to established targets. This is referred to as active risk.

Realized active risk represents the volatility of investment performance returns achieved relative to the target benchmark on a 36 month rolling basis.

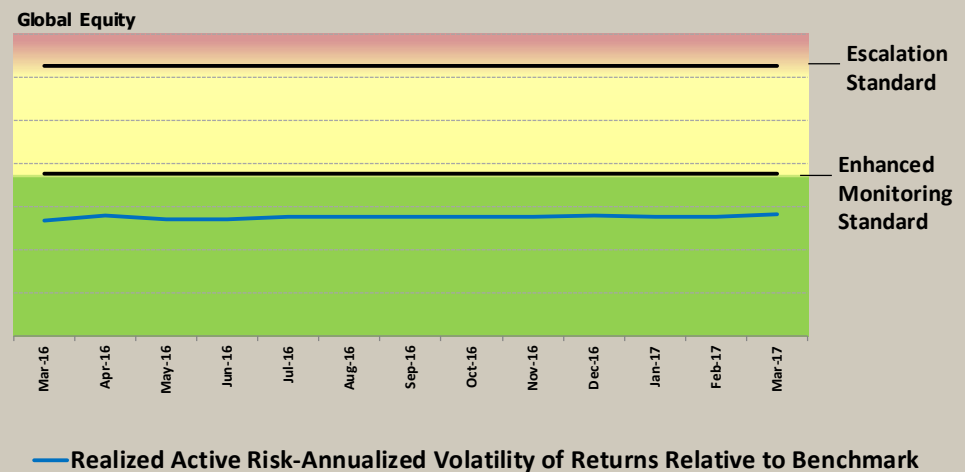
The enhanced monitoring and escalation standards in these charts reflect bands of acceptable active risk levels as established in SBA policy.

Sources, levels, and trends in active risk are regularly evaluated by the SBA Senior Investment Group.

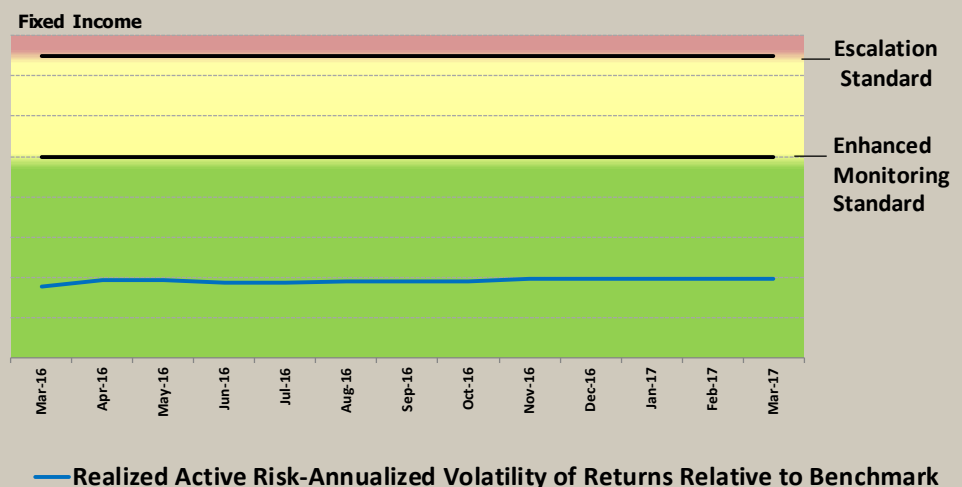
TOTAL FUND RISK



GLOBAL EQUITY RISK



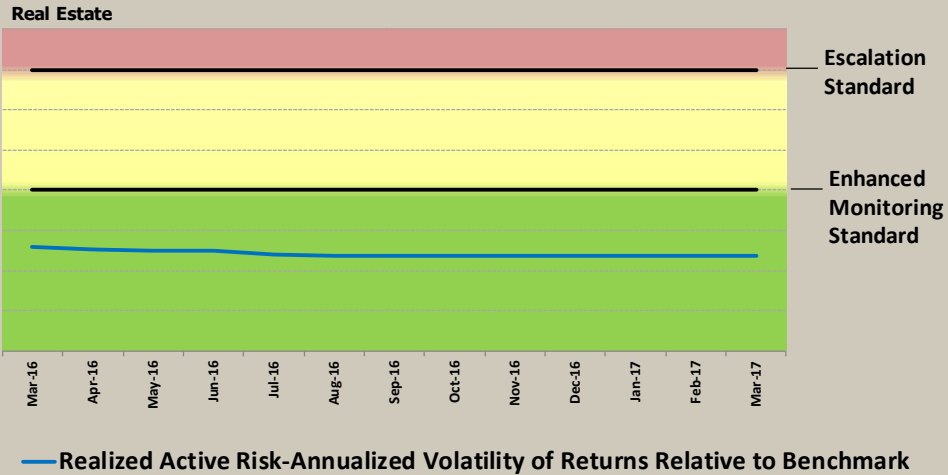
FIXED INCOME RISK



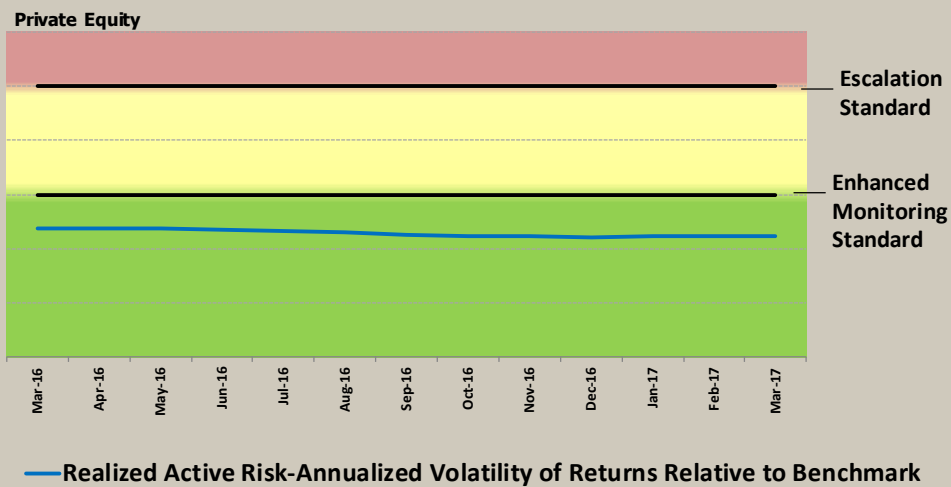

TOTAL FUND & ASSET CLASS ACTIVE RISK

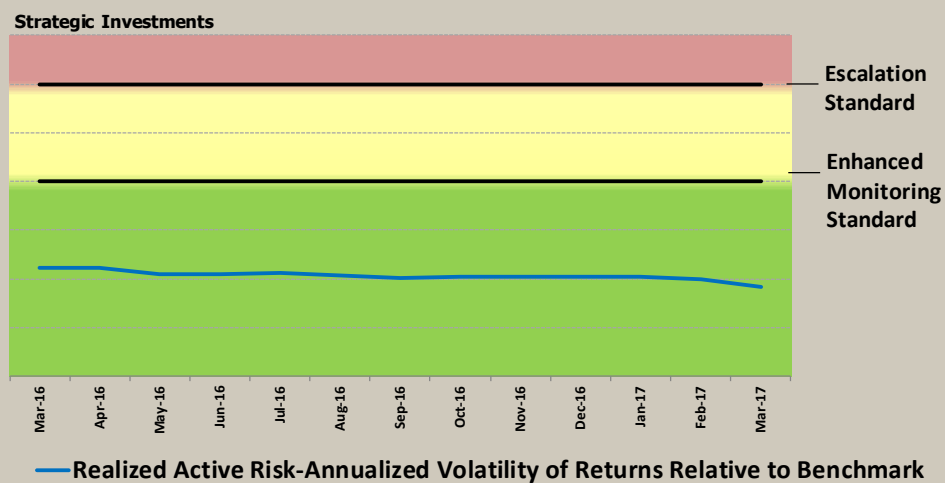
REAL ESTATE RISK



PRIVATE EQUITY RISK

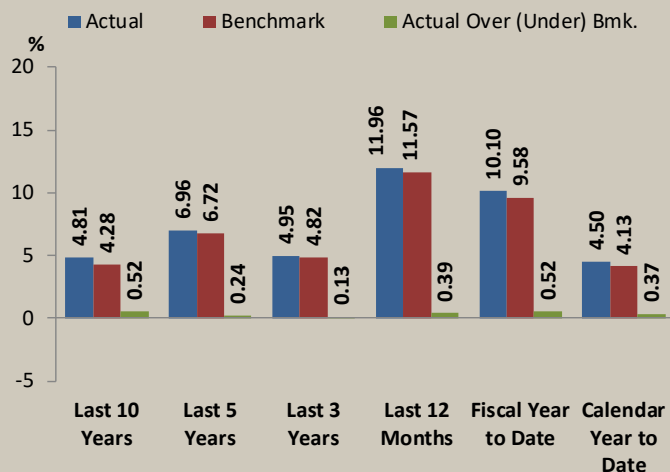


STRATEGIC INVESTMENTS RISK

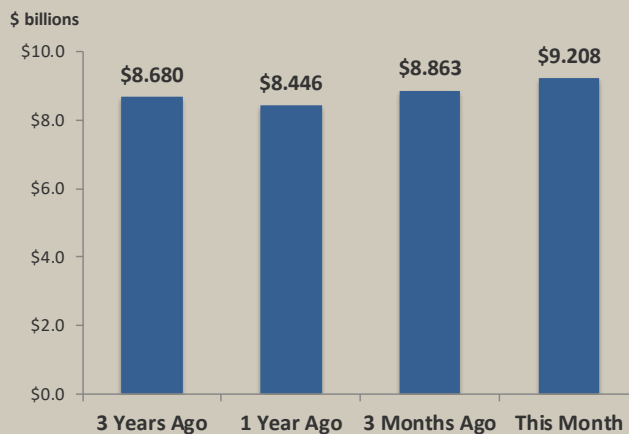

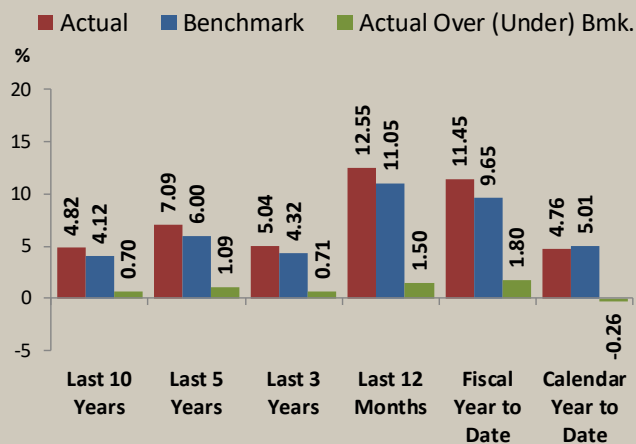

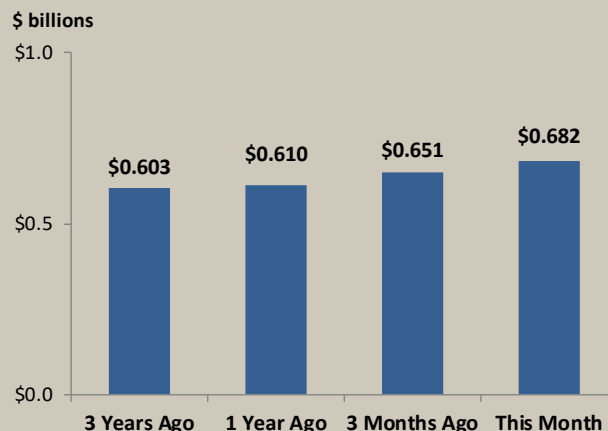

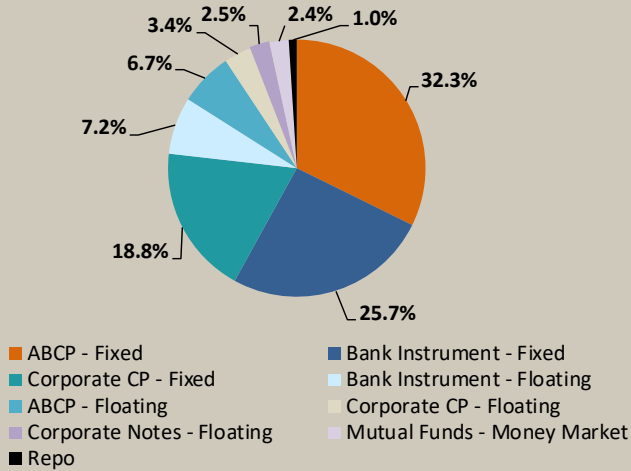

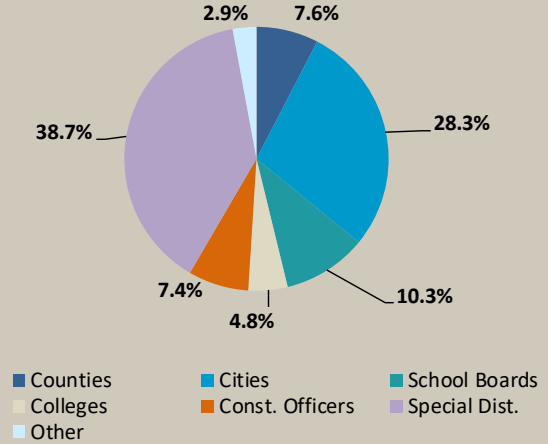

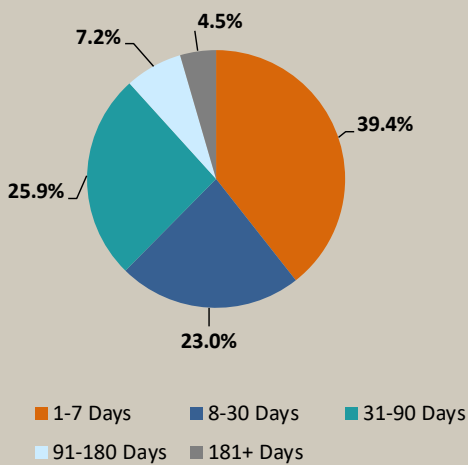
PORTFOLIO COMPOSITION



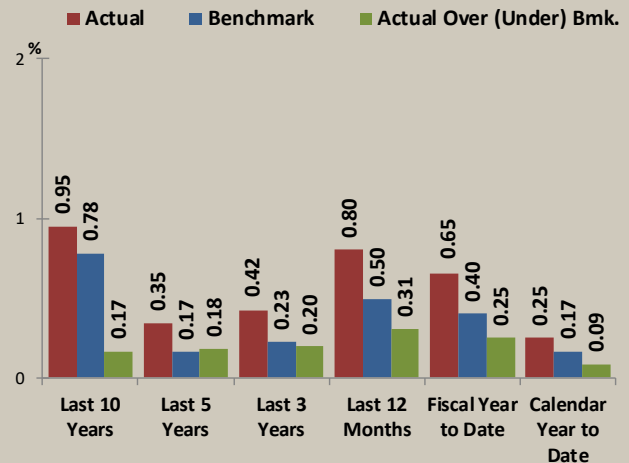
PARTICIPANTS BY TYPE - 728 TOTAL



EFFECTIVE MATURITY SCHEDULE

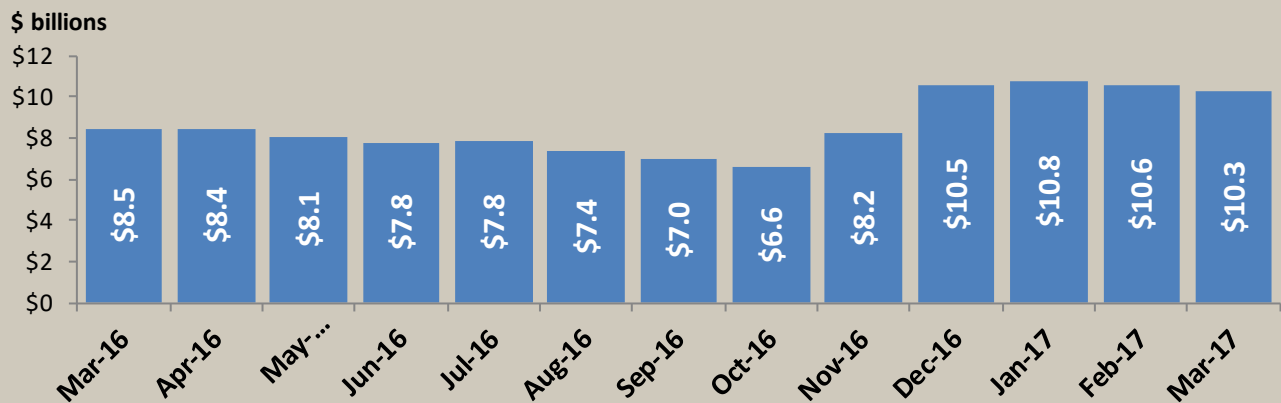

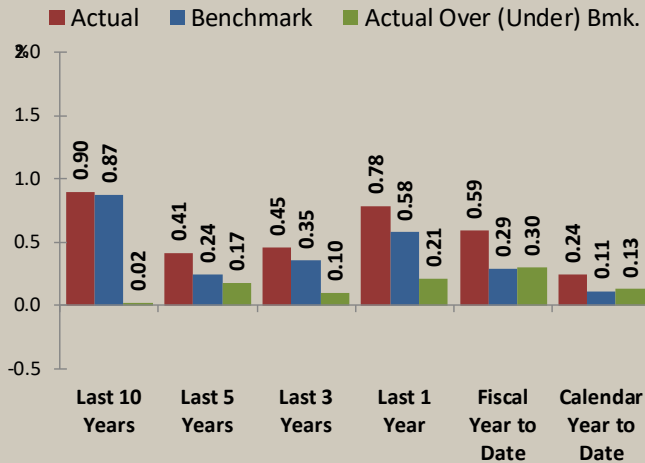

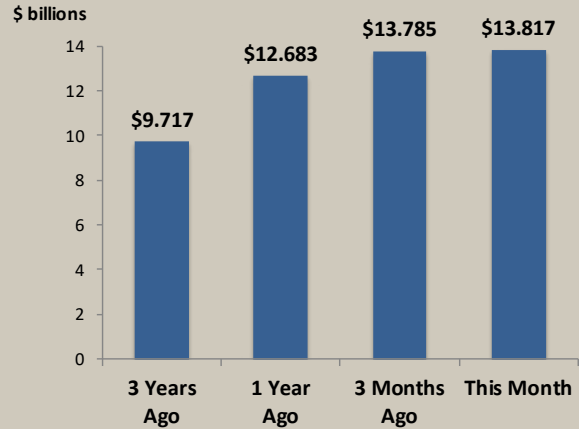


FLORIDA HURRICANE CATASTROPHE FUND

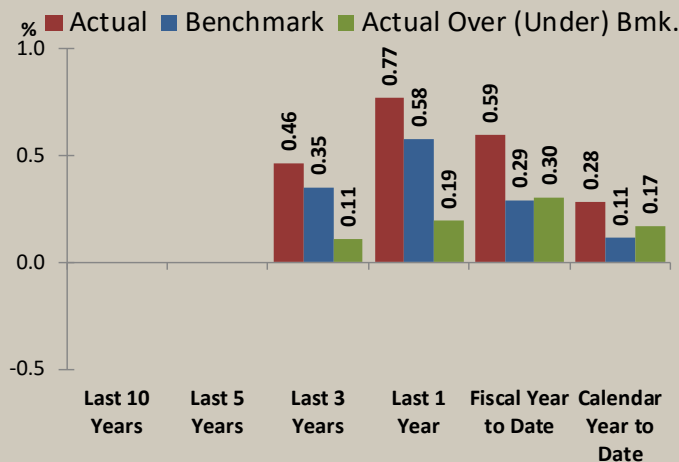
OPERATING FUND PERFORMANCE



OPERATING FUND NET ASSET VALUES



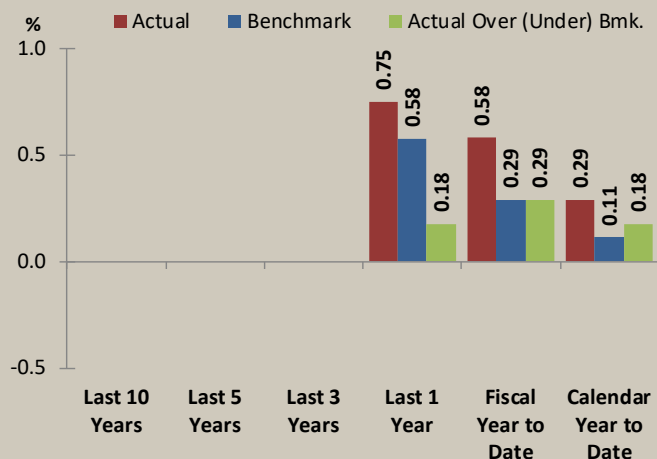
2013A NOTE PROCEEDS PERFORMANCE



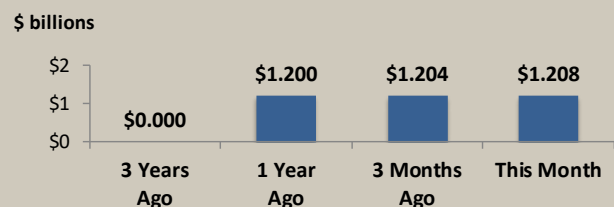
2013A NOTE PROCEEDS NET ASSET VALUES
