## **\$2.96 MILLION IN ADDITIONAL LIQUIDITY AVAILABLE FROM FUND B**

Today, the SBA transferred \$2.96 million from Fund B to Florida PRIME. Cash will be transferred to Florida PRIME participants in proportion to their original adjusted Fund B balances.

The investment objective of Fund B is to maximize the present value of distributions to participants. Fund B cash holdings are being distributed as they become available from maturities, sales, investment interest and other income received from the assets in Fund B.

Since the inception of Fund B in December 2007, the total accumulated distribution has amounted to approximately \$1.92 billion, or 95.6 percent of the original Fund B principal.
